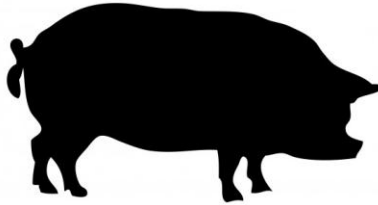


# **Bishopville BBQ Block Party**

The Bishopville BBQ Block Party will be held in Bishopville SC, on April 27-28, 2018. We are offering cash prizes to limited number of barbeque cooking teams. The application to compete in this fun event is limited to the first 20 barbeque teams who apply and are accepted. It is first come first served.

Experienced, trained and certified SCBA judges will handle the judging in this contest. The winners will receive trophies and cash prizes.

Each team may provide their own shelter and will be allocated one 10x20 outside space. If you require a larger cooking area, please describe your reasons, including the sizes of the grills, props, and any other items used in your cooking set- up. You can use the back of the application or attach additional sheets if necessary. We value our barbeque cookers and we want to help you be successful.

A \$200 fee must be received with each application form no later then April 1, 2018. The Chamber of Commerce will provide 1 case of butts and 40 lbs. of wings to each team. The cook-off committee reserve the right to reject any entry. If your entry is not accepted, the \$200 entry fee will be fully refunded.

However, no refunds of entry fee will be made once you have been officially accepted as a contestant.

All rules and regulations stipulated by the SC BBQ Association should be followed for food preparation and judging.

## **Ticketing**

The Lee County Chamber of Commerce will sell tickets on site for \$1 each, and those tickets will be presented to the teams for a sample of barbeque.

Teams should not handle cash at any point during the event. Teams are not allowed to offer direct cash sales to attendees.

## **Rules**

Team placement will be based on space requirements and arrival times. Reserved or requested spaces are not allowed.

Power is provided. It is recommended that each team bring at least one 50' extension cord to hook up to power supply. Power cords will not be provided to teams. Water will be provided and made accessible to each cooker station. It is suggested that teams bring additional approved water hoses to make hook-ups easier.

Please discard of all waste in waste baskets and /or trash bags.

During regular event hours, teams may use restrooms located in the Chamber of Commerce building. After hours, teams must use portable restrooms located around the event area.

Quiet hours are from 11pm-7am. Please be respectful of neighboring teams and residents located around the event grounds.

Bishopville Police have jurisdiction over event grounds and any persons using those grounds.

Each team is required to carry at least one (1) fire extinguisher.

Please adhere to any and all additional policies set forth in the "Cooker Packet" which is sent to each registered team the week before the event date.

Arrival time is between 10am and 3pm on Friday, April 27.
